1 **I. GENERAL PROVISIONS**

2 Nothing in this order is intended to or does supersede any prior Case Management Order in
3 this matter, unless otherwise noted. (See Case Management Order No. 1 dated March 17, 2025
4 (“CMO 1”), Case Management Order dated April 18, 2025 (“CMO 2”), Case Management Orders
5 dated May 15, 2025 (“CMO 3” and “CMO 4”), Case Management Order Dated June 2, 2025
6 (“CMO 5”), and Case Management Order Dated July 10, 2025 (“CMO 6”).

7 **II. INDIVIDUAL PLAINTIFFS’ STEERING COMMITTEE**

8 CMO 1 included the list of firms that shall serve on the Individual Plaintiffs’ Steering
9 Committee. That list is amended as detailed in **Exhibit A**.

10 **III. SUBROGATION DAMAGES DISCOVERY**

11 The provisions of CMO 1 and CMO 2 regarding subrogation damages and claim file
12 production continue to apply.

13 i. Duty of Newly filed Subrogation Plaintiffs to Comply with Damage Compilation

14 Subrogation Plaintiffs who file new actions, and have not previously provided damages data,
15 must provide their damages along with their underlying case number to Subrogation Liaison Counsel
16 via Shannon Turkett (sturkett@bergerkhan.com) within 30 days of their matter being deemed related
17 to the Lead Case (25STCV00731). Subrogation Liaison Counsel shall then provide an amendment to
18 Defendants of the last provided data to reflect the additional carrier(s) within 15 days (45 days from
19 the date the new Subrogation action is deemed related). Carriers who have actions on file as of the
20 date of this order but not yet provided data shall provide such data within five business days of entry
21 of this Order. Thereafter such carriers shall continue to provide updated data in accordance with the
22 existing schedule as outlined in CMO 1.

23 Subrogation Plaintiffs who have already provided data, whether having filed a complaint or
24 not, shall continue to update their data in accordance with the timelines set in CMO 1.
